BREAKING THE CYCLE

SEAN'S STORY

Sean's is a story of resilience and growth, highlighting his capacity to heal from trauma and build healthy connections with his family and friends in the aftermath of relationship violence.

He grew up as an only child in a household with his mother and father where he witnessed his parents arguing. Over time, those arguments escalated. He loved his parents, but Sean started fearing his father after he became physically abusive toward his mother.

"Thank you for teaching me about my emotions." - Sean, age 8

Sean's mother worried about the example that her husband was setting for Sean. But the tipping point happened when she realized that the abuse was already impacting him, as he started waking up every night in a panic from night terrors. After several sleepless nights, she knew that they had to escape this cycle of violence. Sean and his mother moved from shelter to shelter five times in one year. Until they found refuge at Human Options. When they arrived at our emergency shelter, Sean and his mother began their journey toward healing.

At first, as the nightmares continued, Sean struggled to control his emotions. He acted out at school because he found it difficult to communicate his feelings. His mother's case manager recommended that Sean participate in counseling with one of our therapists to help him understand his emotions. He initially resisted counseling because his feelings made him uncomfortable. But he slowly began opening up and building emotional resilience that once seemed out of reach. He started looking forward to his sessions because he learned effective coping skills that helped him make stressful situations less scary. His mother and his teacher both noticed tremendous progress as Sean started making friends at school and opening up to his mother about his feelings.

Recently, with the help of Human Options' Rapid Rehousing program, Sean and his mother moved out of shelter and into a neighborhood closer to their extended family. Together, they built a new home where it was safe to talk about feelings. Today, Sean enjoys spending time with his cousins, continues making friends at school, and talks about his feelings with his mother. In his last counseling session, Sean expressed his gratitude, saying, "Thank you for teaching me about emotions."

EMPOWERMENT HEALS NIKKI'S STORY

Nikki was a trained therapist and entrepreneur thriving in her career. After earning her master's degree in social work, she pursued her dream of launching her own business. When she fell in love, she felt that her personal and professional lives were really taking shape. However, she felt this joy slowly dampen and her progress halt when her partner became controlling and abusive.

For years, Nikki struggled to understand how she—an educated and trained therapist working with others to overcome their own abuse—could find herself in an abusive relationship.

She felt ashamed, and feared what would happen to her reputation if others found out, and so Nikki hid her pain and abuse. But he became more controlling, and his abusiveness became life-threatening. She feared for her life, and despite the shame, fled her home to find safety.

She knew through her own experience in working with survivors that to regain control of her life and remain safe from violence, she needed shelter. That night, Nikki reached out to several organizations across the state but could not find the support she urgently needed. Then she found Human Options. When she called our hotline, a case manager connected her to our Safety Net program and secured a hotel room for the night so that she could leave her home and her partner immediately. The following day, her case manager helped her transition into our residential programs, where she joined a support group with other survivors.

As she listened to their stories, she began to realize that she wasn't alone. When she shared her own story, other survivors just like her helped her accept that she was not to blame. She began to feel less shame and felt empowered to share more about her own experiences, especially as new residents joined the group.

Since joining the program, Nikki has begun to find herself again and regain her sense of security. “Even in the depths of despair, I learned that regaining my voice was my path to empowerment. It’s not about how educated I am, but about having the courage to seek help and the strength to rise again.” Just last month, she launched her media website, where she uplifts stories of women’s empowerment in communities of color.

HEALING & TRANSFORMATION

GABBY'S STORY

Gabby was a dedicated member of her church community, committed to her education and goals, and embraced by a loving and supportive family. At age 18, she fell in love with a man who was esteemed in their faith community, and soon after, they got engaged. She was happy and hopeful about the future.

Gabby doesn't remember exactly when the abuse started, but her first memory was in the car on their way to her family's house for their engagement party. She was shocked. She saw a side of her fiancé that was so different from the man she had fallen in love with.

However, her faith had taught her that forgiveness should be without limit, and so she remained committed to supporting him with his "struggle." During the first years of her marriage, he became more controlling and abusive, especially after the birth of their twin boys, but Gabby never told anyone.

One day, as they were feeding the boys, she told him that she didn't want to raise her children like this. He replied: "If you leave with the boys, I'm going to have you arrested for kidnapping. Gabby, I will kill you." That was her tipping point. "The fear of staying had become worse than the fear of the unknown of leaving and rebuilding my life."

When he left for work, she called her mother, packed up her things, and escaped with her twin boys to a hotel, checking in under a different name. She called the Santa Ana Police Department, and when they arrived, the police officer gave her a card for Human Options and encouraged her to call our hotline.

Gabby enrolled in Human Options' Personal Empowerment Program, where she learned more about what she had just endured and connected with other survivors who showed her that she wasn't alone. During a difficult court battle with her ex-husband over custody of her children, she continued with an additional year of therapy through Human Options where she restored her sense of safety, renewed her resilience, and learned how to help her sons work through the abuse that they had experienced as a family.

With the support of Human Options, she decided that this was not going to be the end of her story. "This program saved my life and made me a better person and mother," Gabby says. Today, she is a supportive mother and successful working professional providing a safe and happy life for herself and her children. She has become a survivor advocate, joining the Board of Directors at Human Options where she supports other survivors who seek transformative healing by sharing her story and helping us secure resources for our continued and expanding survivor-driven services.

Her advice to other survivors: there is a way out and a life on the other side. "I'm living what I thought was impossible."

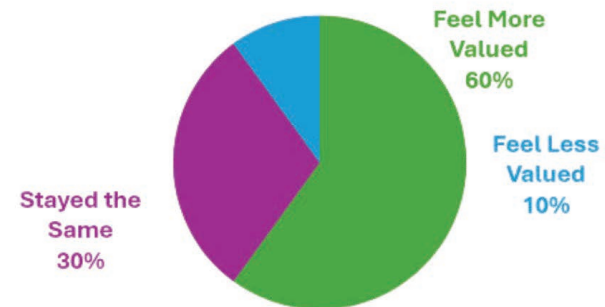

We have used Human-Centered Design to guide innovation in our programs and services, and this has had a profound impact on survivors, their families, and on Human Options. It places survivors of relationship violence at the heart of developing solutions, ensuring that their needs, experiences, and voices guide the process. Grounding ourselves in empathy has been essential to this process. It fosters deeper understanding, builds trust, and drives meaningful, survivor-centered outcomes.

It offers validation and empowerment.

When we listen with empathy, survivors feel heard, and their experiences are validated. “It’s affirmation that I’m not crazy,” one survivor claimed with relief. This breaks the isolation and shame associated with relationship violence. Survivors often hear that no one will ever believe them, and so simply listening with empathy fosters empowerment, transforming their stories into tools for awareness and change.

It fosters healing and growth.

Sharing their stories allows survivors to move from victimization to empowerment, reclaiming control over their narratives and transforming their pain into purpose. As one survivor shared, “It gives me confidence to stand in my truth.” It validates their journey and reinforces that their voice matters, which is critical for rebuilding self-esteem and confidence. Survivors who share their experiences have discovered an inner strength and resilience that fuels their personal transformation.

It humanizes our process. Empathy uplifts survivors as valued individuals with unique stories, aspirations, and contributions to their own healing. Solutions rooted in empathy and survivor input are more sustainable because they resonate deeply with the community we serve. Upon seeing a prototype for a new outreach strategy driven by survivor input, one survivor noted, “This would have changed my life.” Empathy-driven processes create ongoing dialogue, allowing solutions to evolve alongside survivors’ changing needs.

It improves our services.

Human Options is learning directly from survivor experiences, enabling us to design more effective, survivor-centered tools and services. By uplifting survivor voices, we affirm that agencies respect and value their input, fostering trust and encouraging our partners to engage empathetically. “I feel heard, and that is a valuable experience,” shared one survivor. By centering survivor voices, we can tailor services to address underlying barriers rather than focus on symptoms.

A year of listening with empathy has reinforced our belief that survivor stories have the power to shape innovative responses to their needs. We are steadfast in our commitment to listen to survivors, learn from their experiences, and uplift their journeys so that our services are more accessible and transformative. Survivors are empowered to use their stories and experiences as tools that can transform the futures of survivors everywhere.

We will continue to integrate Human-Centered Design as a way of inspiring collective empowerment. Because when we listen to survivors, it inspires a ripple effect of empowerment, encouraging others to speak up, act, and contribute to Orange County’s transformation.

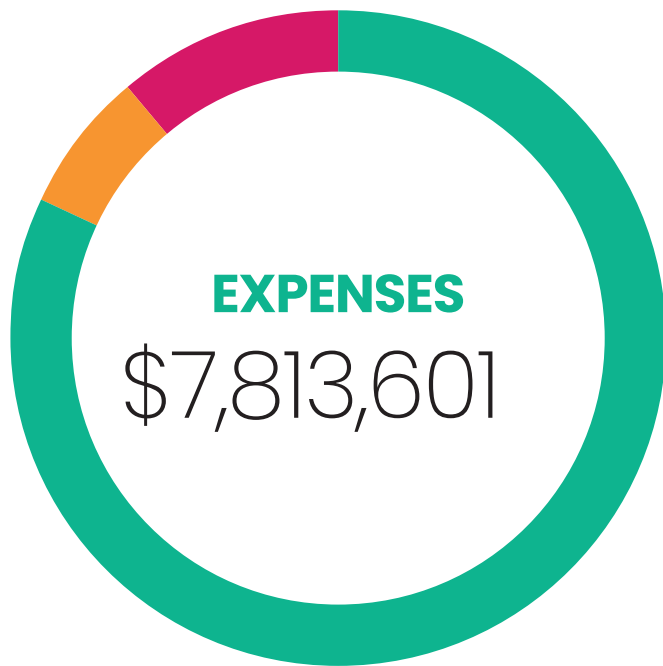
