# ONE PERSON'S POWER – FROM SURVIVOR TO ADVOCATE

## AMBER'S STORY

Amber was a young girl when she first knew something at home wasn't right. One night, she stood in the hallway, watching her parents through the bathroom door. Her mother was pleading as her father hurt her. Amber didn't have the words to fully understand her experience then, but she told herself, "This isn't right. This will never be me."

By the time Amber was a teenager, the danger had evolved. The threats against her mother escalated. At one point, her father told Amber's mother he would shoot her—not to kill her, but to make her suffer. Her mother knew they had to get out.

She made a brave decision. One night, she came home, gathered her two daughters, and drove them to her sister's house. Amber's aunt saw the fear and urgency and spoke up. She connected Amber's family to Human Options. That single act of courage opened the door to her family's next chapter and a pathway to transformation.

At Human Options, Amber, her sister, and her mother received family therapy, shelter, legal support, and resources they never knew existed. Advocates listened without judgement, guided them with compassion, and helped them reclaim their future.

Amber now sees the patterns clearly. The violence she witnessed was part of a cycle shaped by trauma, learned behaviors, and silence. But she chose a different path. She broke the cycle, rewrote her story, and gave her daughters the life she never had.

Today, Amber is a mother of two, a homeowner, and a partner to her high school sweetheart. Her life is filled with love, laughter, and possibilities. And it all began with one person who saw her family's pain and chose to act.

Amber is now that person for others.

As a member of Human Options' Survivor Advisory Council and its representative on the Board of Directors, Amber brings a rare and powerful perspective. She's the only council member who lived in shelter as a teen and now gives back as an adult. Her insights shape how Human Options serves children and teens, ensuring they feel safe, seen, and supported.

Amber was once the child who needed someone to speak up. Now, she's helping us listen better, act faster, and offer a deeper path to healing.

# A STORY STILL BEING WRITTEN

## YASMIN'S STORY

Yasmin was a single mother determined to give her daughter a better life. She dreamed of studying psychology to help others in need and hoped one day to find someone who could give them a family.

Eventually, she met someone. At first, it felt like a new beginning. But slowly, the signs emerged. After arguments, she found herself saying, "It's okay," when it wasn't. When she was out with friends, she laughed off his hurtful comments. In public, she shrank so he wouldn't accuse her of being "too much." Over time, Yasmin started to believe that being loved meant being less.

By the time the physical abuse started, she was too afraid to act. Something as simple as a house key became a weapon of control. Her partner refused to give her a spare, and when she held onto the only one, he dragged her to the ground, tore her purse apart, and kicked her in the head. Her ears rang. When he asked, "Do you want me to kill you?" she thought, "Yes, just end it."

Thankfully, Yasmin's story didn't end there.

Her mother-in-law, herself a survivor, recognized the signs and understood Yasmin's fear. She knew what it meant to be trapped and how to

help. When Yasmin's abuser planned to be away for several days, she saw a window to escape. She packed her car, left the key behind, and drove away. Then, her mother-in-law became that one person who changed everything, connecting her to Human Options.

When Yasmin entered our residential program, she felt something she hadn't felt in a long time: safety. Our advocates welcomed her without judgment, listened with compassion, and made her feel seen. Over time, she found a therapist, secured her own apartment, and held her new keys in her hand. They were no longer a symbol of control, but of safety and empowerment.

Yasmin reclaimed her determination, juggling school, work, and therapy all at once. She re-enrolled in school and began studying psychology. She had spent years in fear, and is now creating a life defined by strength, purpose, and choice.

"I feel like a changed person," Yasmin says. "I feel like I can overcome anything. I can do anything."

Yasmin holds the keys to her own future. And her story is still being written—for herself, her daughter, and the next generation.

# THE POWER OF YOU: LISTENING, LEARNING, AND LEADING WITH HEART

## Relationship violence is everyone's concern.

Last year, Human-Centered Design became a guiding force at Human Options—placing survivors at the heart of how we innovate, listen, and respond. That culture shift sparked something deeper: a commitment to not just hear survivor stories, but to have them guide our next steps. This year, that commitment came to life through three bold initiatives—each one rooted in survivor voice and designed to deepen understanding, create empathy, and spark action.

Human Options' **Survivor Advisory Council** has officially launched, marking a significant milestone in our mission to ignite social change and support survivors at every step. The Advisory Council provides strategic input on program development, policy recommendations, and community outreach. Composed of five dedicated members, the Council is already making an impact. Notably, two members courageously addressed the Board of Supervisors, sharing personal insights into the profound impact that the loss of Family Resource Center funding would have on survivors in our community. We believe that their stories inspired the Board of Supervisors to act to restore funding. Additionally, one member stepped forward to share her powerful story on the inaugural Courage Over Comfort live podcast, bringing a vital survivor perspective to a broader audience.

Beyond these achievements, we are deeply inspired to witness the strong bonds and meaningful connections beginning to form among the Council members. Their expertise, lived experience, and growing unity are already showcasing the power of a caring and empathetic community.

With the support of the Advisory Council, we launched our second initiative, **Courage Over Comfort**, a four-part live podcast series. Courage Over Comfort embraces vulnerability and holds space for brave conversations that are vital to breaking cycles of relationship violence. The word courage comes from the Latin “cor,” meaning heart. Courage in its simplest form is the ability to tell one's story with your whole heart. In this space, we recognize that both sharing and listening to these stories creates discomfort. That discomfort matters and is often where the breakthrough in our collective understanding begins. In our first episode, Survivor Advocacy Council member Amber Tran joined Dr. Liza Eshilian-Oates, a Kaiser Permanente physician and Human Options Board Member, to explore the intergenerational cycle of abuse. They highlighted how relationship violence impacts children and how medical professionals can recognize the signs and intervene. Their conversation revealed how compassion, curiosity, and training can transform a survivor's experience and connect them to help.



The stories of survivors have shown us that transformation happens when a community walks alongside them. Their stories showed us that individuals have the power to make a difference, and when the Human Options community comes together, that impact multiplies. The vision is at the heart of **Humanity in Action**, our third initiative, a collective movement to end relationship violence in Orange County. Launched in May, this volunteer and community engagement initiative emphasizes that change doesn't look one way; it harnesses everyone's unique talents. Already, volunteers from the Insurance Industry Charitable Foundation donated a \$10,000 grant and renovated our Children's Program space at the emergency shelter, transforming it into a place of healing and reconnection. Humanity in Action invites individuals to make an impact across four areas: connecting people to help, strengthening

families, creating safe spaces for survivors to speak their truth, and building networks that make institutions—workplaces, churches, service providers—ready to respond.

Together, these three initiatives reflect our belief that empathy is the starting point—and action is the outcome.

This is how we make relationship violence everyone's concern.

# COMMUNITY SPOTLIGHT: **CAPITAL GROUP – THE POWER OF YOU IN ACTION**

This Community Spotlight highlights the profound impact of **Humanity in Action** and the incredible results that happen when individuals and organizations unite to support survivors. Through the partnership with Capital Group in Irvine, both financial contributions and hands-on volunteer efforts demonstrated how collective creativity, compassion, and connection can make a lasting difference.

The story began with a simple conversation between our board member, Andrew Gray, and his friend, Brian Clark of Capital Group and a shared desire to help children affected by relationship violence. What started as a small act of giving quickly blossomed into a meaningful collaboration between Human Options and Capital Group. Employees became inspired to learn more about the needs of survivors and discovered common ground in using human-centered design to shape positive, survivor-focused outcomes. Together with Human Options, the team identified the Children's Program at a transitional housing site as an area ready for transformation.

Instead of making assumptions, the volunteers took the time to listen directly to survivors, parents, and teens about what would make the space truly supportive and safe. The feedback was clear: teens needed a dedicated area of their own and families wanted a communal space to connect

and heal together. Guided by these insights, the team thoughtfully reimaged the program areas, designing new layouts, murals, and furnishings that reflected the hopes and needs of those served. With a generous grant and more than forty volunteers contributing their time and talents, the transformation was completed in just two days. The program space, once suited only for young children, was redesigned to serve youth up to 17 years old. Two distinct environments emerged, one for younger children and another for teens, each fostering connection and growth. The immediate joy and sense of belonging felt by children and families affirmed the positive impact of this collaborative effort.

This partnership's influence did not stop with the renovation. Volunteers continue to support Human Options through ongoing giving and advocacy, demonstrating how powerful change happens when people and organizations connect their skills, resources, and hearts to a shared cause. The ripple effect of their involvement continues to spread, sparking new opportunities for healing and hope.

This story captures the essence of Humanity in Action: anyone can make a difference by using what they have—skills, networks, resources, or simply a willingness to listen and help. One connection, fueled by compassion and community spirit, can grow into a transformative partnership that creates safe, welcoming spaces for survivors and their families.

This is the power of you coming together.

# AWARENESS CAMPAIGNS

At Human Options, we strive for a future where every person can live free from fear and violence. Our dedication to this mission is constant, but there are pivotal moments each year when our impact is most deeply felt, when our voices echo louder, our community bonds strengthen, and real transformation begins.

In 2024, our Shine the Light Walking Vigils emerged as powerful beacons of remembrance and resilience in Costa Mesa, Irvine, and Santa Ana. Each gathering was not only a tribute to those lost to relationship violence, but also a celebration of survival and healing. These vigils transform public spaces into sanctuaries of hope, where survivors, advocates, and community members stand together, reclaiming the streets and demanding lasting change.

Our awareness campaigns reached thousands, challenging stigma, promoting healthy relationships, and empowering individuals to act. We believe that awareness opens doors—and that every voice can spark prevention.

By joining forces with cities, collaborating with local governments, law enforcement, and grassroots organizations, we are building a unified response centered on survivors and meaningful systemic change. These partnerships are the heart of our work, forging spaces where survivors feel truly safe, supported, and empowered to seek help.

City vigils embody this commitment. When a community publicly confronts relationship violence and declares, “You are safe here,” it sends a resounding message of hope. At the Costa Mesa vigil, a survivor—moved by the sense of safety and solidarity—stepped forward for help and found refuge in our emergency shelter that very night. Her story is a testament to the transformative power of community, turning awareness into action and cities into safe havens for healing.

These vigils go beyond honoring those lost; they build trust, break silence, and open pathways for survivors to access vital services. Together, we demonstrate that united communities can create real change and every survivor can discover the courage to step into safety and healing.
